Starting Time: 9:00 AM with registration at 8:00 AM

Eligibility: Any individual familiar with safe firearms practices and who support the right to keep and bear arms are welcome. Competitors must be legally eligible to use firearms. NRA & WSSA membership is encouraged but not required. M1 Garands must be as issued.

Match Fees: \$15.00 per shooter

Safety: NRA rules apply. Open bolt indicators are required. All rifles must be in the case or have the actions open and the empty chamber indicator inserted except when the competitor is in position for the preparation period and live fire.

Ammunition: Any safe ammo, except tracer or incendiary and AP .30-06 ball will be available for purchase.

Targets: NRA - SR

Awards: Cash awards for individual matches and aggregate

Course of Fire: All firing is at 200 yards. This is a no alibi match. Sighters - 5 sighters will be taken from the prone position prior to match 1, all sighting and slow fire shots will be single load.

Match 1 - Slow fire prone, 10 shots from the prone position in a time period of 10 minutes. Sling support only.

Match 2 - Rapid fire prone, shooters will start in the prone position and fire 10 shots in a time limit of 70 seconds, 2 shots followed by 8 shots after reload.

Match 3 - Slow fire standing, 10 shots fired from the standing position in a time limit of 10 minutes.

Match 4 - Aggregate of matches 1, 2 and 3

Starting Time: 9:00 AM with registration starting at 8:00 AM

Eligibility: Anyone 16 years of age or approved by match director. Competitors must be legally eligible to use firearms. NRA & WSSA membership is encouraged but not required.

Match Fees: \$15.00 per shooter for July and August matches

Safety: NRA rules apply. No muzzle breaks allowed. Open bolt indicators are required. Assistance and coaching is allowed only during sighter period. Unlimited sighting shots are taken prior to the first record shot in all matches.

Rifles: Any rifle/Iron sight, any rifle/any sight. Service rifle, F Class and F/TR

Classification: NRA midrange classifications, F Class and F/TR Classification, any competitor that has previously fired a midrange match is classified.

Ammunition: Any safe ammo, except tracer or incendiary and AP .

Targets: Rule 4.6 MR-1, MR-1F

Awards: Cash awards for individual matches and aggregate

Course of Fire: Except for State Match

Match 1- Any rifle/ any sight unlimited sighters, 20 shots for record in a time limit of 22 minutes

Match 2 - Any rifle/ any sight unlimited sighters, 20 shots for record in a time limit of 20 minutes

Match 3 Any rifle/ any sight unlimited sighters, 20 shots for record in a time limit of 20 minutes

Match 4 - Aggregate of matches 1, 2 and 3

All competitors will perform pit duties and scoring duties
