


# 2021 WYOMING MID-RANGE STATE CHAMPIONSHIP



## HOSTED BY THE PLATTE RIVER R&G CLUB

**MATCH DATE:** June 26<sup>th</sup> & 27<sup>th</sup> 2021

**LOCATION:** Platte River Rod & Gun Club, Poison Spider Range; Take US Hwy 26 west of Casper and turn south on 10 Mile Rd. Follow to Zero Rd and turn right heading west and then south as it becomes the Poison Spider Rd. After cresting hill and just before the school turn left on 12 Rd. Watch for the Platte River R&G Club on the left.

Approx GPS to front gate is about: N 42° 49' 15.39", W 108° 33' 12.11"

**TIME:** Registration Opens at 0800, Closes at 0845, Firing will commence around 0900 MDT.

**MATCH DETAILS:** NRA Registered Match. The Match Director may make changes because of weather, competitor physical conditions, and types of entries, or other circumstances. Bring your own food and water. You can compete with iron sights or scope in this event.

**ELIGIBILITY:** Any individual familiar with safe firearms practices, and who supports the rights of citizens to keep and bear arms will be allowed to shoot. NRA membership is encouraged, but not required. Resident State Club Assoc. membership encouraged, but not required. Note: non-members/affiliated competitors charged a higher fee, and are not eligible to set national or state records. See Fee's & Awards below for details.

**RULES:** Current NRA High Power Rules will govern. See NRA rules on line at:

Use of an "Empty Chamber Indicator" (ECI) is required in all NRA matches and may be purchased for \$2.00 at registration. Hearing and eye protection are required on the firing line and in the target pits. No Muzzle Brakes, Compensators, Sound Suppressors!

- CHALLENGE FEE:** \$2.00. The challenge fee must be paid at the time of the challenge.
- AMMUNITION:** Tracer, incendiary, or explosive ammunition is NOT allowed. Safe ammo only!!
- FIREARMS:** Service Rifle (Rule 3.1), Any Rifle (3.2), NRA Match Rifle (3.3), Palma Rifle (3.3.1), NRA Mid-Range AR Tactical Rifle (3.3.3) NOTE: Competitors competing under provisional Rule 3.3.3 are not allowed to win the match, or be combined in other categories, but may eligible for awards in their own category if there are at least 3 competitors in category.
- Categories:** Competitors/Shooters will be placed into one of the following categories:
1. F-class Open (Rule 3.4a)
  2. F-class Target Rifle (Rule 3.4b)
  3. NRA-Any-Match-Palma Rifle (Rules 3.2, 3.3, and 3.3.1)
  4. Service Rifle (Rule 3.1)
  5. AR Tactical Rifle Mid-Range, (Rule 3.3.3)
- Except for A R Tactical, Categories with less than 3 competitors will be combined for award purposes.
- CLASSIFICATION:** NRA classification system will be used. Unclassified competitors will compete in the Master Class, (Rule 19.2, or 19.6 or 19.14)
- SQUADDING:** All matches will be squadded. All competitors will be expected to shoot, score and perform pit duty.
- TARGETS:** MR-1, (Rule 4.6) & for F-Class MR-1FCA (Rule 4.6)
- COURSE OF FIRE:** Rule (7.20) ALL MATCHES WILL BE SLOW FIRE 600 YARDS PRONE! Competitors will be allowed 22 minutes, and unlimited sighters shots, but must tell their scorekeeper when to start record fire!!!
- MATCH 1:** Unlimited sighter shots, 20 rounds for record, time limit of 22 minutes.
- MATCH 2:** Unlimited sighter shots, 20 rounds for record, time limit of 22 minutes.
- MATCH 3:** Unlimited sighter shots, 20 rounds for record, time limit of 22 minutes.
- MATCH 4:** Unlimited sighter shots, 20 rounds for record, time limit of 22 minutes.
- MATCH 5:** Unlimited sighter shots, 20 rounds for record, time limit of 22 minutes.
- MATCH 6:** Aggregate of MATCH 1-5
- NOTICE:** Unlimited sighting shots will be allowed in all matches. It is the shooters responsibility to let the score keeper know when the shooter will go for record fire.

**AWARDS:** All Categories must have 3 competitors or they will be combined with a like group. Monetary awards will be given for each match, in all categories, with a minimum of 3 competitors. AR Tactical Rifle competitors can only

win their category. Overall Match winner in each category (match 6) {except for A R Tactical} that are current residents of their state shooting association, will have their name engraved on the WSSA Sponsored Mid-Range Trophy. At the Match Directors discretion, monetary awards possible in each classification if there are 3 competitors in class. If fewer than 5 High Masters are entered in each category, they will compete for match winner awards only. The High Wyoming resident in each category with 3 competitors will receive a Wyoming Champion Shooter Cap.
