PRESIDENT'S COLUMN

While insanity may reign in the district of criminals and in several of the states, reason and logic still prevail in Wyoming. Nowhere is this more evident than in our fine legislature.

Amid all of the doom, gloom and rumors of impending disaster, rays of sunshine are starting to dissipate the darkness. A bill has been introduced to put teeth into the pre-emption law, subjecting local "authorities" who flaunt this law to become personally liable for civil damages. Another bill removes the restriction on concealed carry permit holders from protecting themselves and others on school grounds. A third bill nullifies any federal restriction on semiautomatic firearms and magazines, criminalizing any outside enforcement efforts. Proposed legislation would also remove the unreasonable restriction on the use of suppressors for hunting.

There has been much depression in the Freedom Community of late. We can hardly hear ourselves over the howling of the anti-gun crazies. However that howling also served a useful purpose. Many are those hitherto either ignored the threat or convinced themselves to believe they were not threatened. Resolve has never been higher and battle lines and lines in the sand are being drawn as never before. I well remember 1968 and 1994 and while unpleasant years, they were nothing like 2013 in this regard.

Following is an excerpt from the Oct-Dec. 2004 President's column. Truly, the more things change, the more they remain the same.

"The final death throes of the "assault weapon" ban offered up many amusing moments. Foremost among these was Sell Diane Feinstein's [D-Kalifornia] shrill, hysterical ranting which surely must have removed anyone's last doubts regarding her mental stability. She seemed to have been especially pushed

over the edge by President Bush's shrewd silence. What the Wicked Witch of the West could never begin to understand is that while no normal, rational person would respond in kind to the barking and snarling of the neighborhood dogs, equally futile and irrational would be to verbally reply to the two-legged dogs who are oh so much more distasteful and dangerous. While the former may defecate on and damage your lawn, the latter deposit their poisonous leavings onto all those things we hold most sacred; the clean-up infinitely more difficult."

HUNTING & CONSERVATION

The year 2012 was not a good year for Wyoming, either for the hunters and fishing people or the game and fish commission. Dry conditions prevailed and had a negative effect on both game and fish. The effect of the wolf and other predator problems in northern and western Wyoming did not improve the situation either it served to discourage trips where there was a lack of game and water. The economy is also having a negative effect—on the game and fish commission—with fewer trips to the field by financially stressed population from both in-state and out-of-state. Wasting disease is yet another deterrent. These situations may very well translate into higher license fees in the near future according to a report by the Wyoming Business Report magazine.

Currently, 76% of all license fees come from out-of-state licenses, a matter of concern to residents since their input is not as heavily weighted as in the past. The hunting, fishing, and wildlife viewing industry are currently a 1.2 billion dollar industry to the state. With a slumping economy and adverse weather conditions due to continued dry weather patterns, the G&F department is looking for additional revenues which could easily translate to higher license fees. Either that or they will have to trim back on some programs they are trying to continue or expand. This might be the most appropriate solution since the population is now having to trim back due to adverse economic conditions affecting them in general economy and mineral industries.

It is generally the trend for an increase in taxes to occur at least appropriate time for the population itself which is during a recessionary period like we are currently getting into. My take on the situation is that the G&F commission should be willing to share in that pain by trimming their own programs just like all of us out in the general population are going to have to do. So far, out state government has shown far more restraint in controlling costs than our government people in Washington DC have. I encourage you to let your G&F representatives at their annual meetings around the state know you appreciate their restraint on increasing expenses and fees until times get better and at the same time realize that with this may come a curtailment of some services they can offer.

Wyoming State JO Championships

The 2013 Wyoming State USA Shooting Junior Olympic Smallbore and Air Rifle Championships was also the inaugural match for the Laramie County Shooting Sports Complex. The shooting sports complex opened its doors after twenty plus years of planning and close to two years of construction. It was worth the wait although I wish there had been more shooters there to enjoy it.

We only had three smallbore competitors two from Cheyenne and one from Niwot Colorado.

Men's State and JO Champion was Austen Williamson, Cheyenne, with a score of 526 Women's State and JO Champion was Jodi Ross, Cheyenne, with a score of 515.

Both received the JO Gold Medallion, The State Champion Plaque and an invitation to the Nationals. Both men and women shoot a 3 position 60 shot match at the state level. At the nationals the men shoot a 3 X 40 shot match and the women shoot a 3 X 20 match

The air rifle matches drew a few more competitors, Twenty total split evenly between the men and women. Air rifle at the state and national level are 40 shots for the women and 60 shots for the man from the standing position.

Men's State and JO Champion was Austen Williamson, Cheyenne with a score of 570, JO Gold Medallion, State Champion Plaque and an invitation to the JO Nationals, 2nd William Gifford, Casper, with a score of 455, JO Silver Medal.

3rd Dylan Hager, Casper, with a score of 415, JO Bronze Medallion.

Women's State Champion, Shannon Draeker, Niwot, Colorado, with a score of 373, State Champion Plaque

Woman's JO Champion, Jodi Ross, Cheyenne, With a score of 372, JO Gold Medallion and an invitation to the JO Nationals. (Note you have to be a resident to win the JO awards but not the State Championships.)

2nd Marin Dey, Cheyenne, with a score of 336, Silver JO Medallion

3rd Ashley Swearingen, Cheyenne, with a score of 322, Bronze Medallion.


WORDS FROM A CHAMPION
