PRESIDENTS COLUMN

It is only through a study of the past that one is able to view the present in the proper perspective. I would like therefore to share a little known nineteenth-century episode: The Coal Creek War.

East Tennessee had an active coal mining industry in 1891 and in that year the miners made bold enough to demand that the coal companies follow state laws which prohibited the use of scrip payment for wages and the use of company checkweightmen. The scrip could only be used at expensive company stores or redeemed for cash at a steep discount. Company checkweightmen determined how much coal each miner produced (the miners being paid by how much coal they produced and they wanted their own checkweightmen).

Most mine owners gave in, but several of the largest companies refused to do so. They contracted with the state to hire convict labor and the miners were evicted from the company owned housing. The houses were torn down and the lumber used to build a stockade to house and confine the convicts. Tennessee was essentially bankrupt after the Civil War and had found it cheaper to lease out convicts than to build a penitentiary.

In July of 1891 hundreds of stricking miners overwhelmed the guards, forced open a stockade, and then marched the convicts to the nearest railroad station where they were put on a trail to the state capitol. The governor, not amused, returned the convicts, along with three companies of the state militia. Things went quickly downhill from there.

This being a column and not a treatise, I will leave it to you the reader to look upall the details of this interesting aspect of our nation's history. I will say that the Coal Creek Was lasted, by fits and starts, well into 1893. Stockades and company property were burned, convicts released, and many dozens of miners and militiamen were killed and wounded.

While technically, the miners lost, in reality the Coal Creek War brought about some needed changes. The cost of keeping the militia in the field greatly exceeded the return from the leasing of convicted labor, so Tennessee ended the practice and built a state prison.

As for repercussions, the governor was voted out of office and most all of the miner's leaders fled the state to avoid prosecution. Those miners brought to court were mostly acquitted or fined. Only one of the leaders went to prison for two years.

How does this obscure story of 120 years ago concern us, the twenty-first century Wyoming gun owner? Plenty, I would think.

Americans of the past showed plenty of gumption, a quality sorely lacking today but not completely extinct. Hopefully, in Wyoming some of that boldness of spirit still exists in the hearts of enough of us who grow increasingly tired of an increasingly lawless, unconstitutional, intrusive, corrupt and oppressive government.

Something else I would hope for. That enough Wyoming sheriffs would do the right thing such as their 1890s Tennessee counterparts did when they either refused to assist the militia or did so very half-heartedly.

The most important lesson, of course, is that without firearms the miners would have had to accept whatever abuses were delivered upon them.

Greetings and best wishes for the new year.

January, 2014 reminds us it's time to get our new fishing licenses and conservation stamps. Also day and overnight permits for our State parks.. You can also get an early bird discount on State park day use permits until February 15th.

There are some new regulations this year for those of you who fish and they can be checked out in the new regulation booklet. There are also some new bison hunting regulations that when sent out were technically correct but have been changed for some wording clarification.

As one method to address recent budget cuts is by increasing license revenue, on January 2, 2014 the Wyoming Game & Fish Department will begin selling tickets for 2 raffles. The Super Tag and the Super Tag Trifecta. This will provide a chance for hunters to win 1 of 10 tags for our most popular big game and trophy game species as well as bison. The super tag trifecta ramps it up a notch by providing 1 winner the opportunity to select tags for 3 of the 10 species. There are many questions about this so the Game & Fish has posted Question & Answer section on it's website.

One subject that is raising an increased wave of concern in Wyoming and surrounding states is wild-life diseases. The diseases seem to be affecting more and more wildlife. There are studies and sample collections going on in multiple states. Hopefully, the samples and information we as hunters & fisher-men provide will help lead to some solutions on reversing this trend. The Game :& Fish on their website has made it possible for your input into planning meetings around the state. So get your ideas and input into these meetings online without being there.

WYOMING STATE JUNIOR OLYMPIC RIFLE COMPETITION

The new range at Cheyenne hosted the event Jan 12th under the direction of Dick Smith. Twenty three shooters did their best to shoot out the tiny '10 dot' on the tough air rifle target.

Mens division with a 600 being the possible score.

Austen Williamson, Cheyenne earned the Champion trophy and gold medal for his 541 Kyle Fox, Carpenter, took the 2nd overall and silver with a 501. Lander J3 shooter, Flint Pokorny, needed a tie breaker to take 3rd overall and the bronze.

The J2 age bracket had Ian Sanford, Casper on top with 448 for the gold. Coulter Anderson, Midwest, took the silver with 408. Bronze went to Jeffery Pike, Casper, with 386.

Anthony Baca, Cheyenne, won the gold in J3 by posting a 366

Womens division with a 400 point possible.

Marin Dey, Cheyenne, topped the field with a 359 to win the Champion trophy and gold medal. Ashley Swearington, Cheyenne, posted a 345 to take the silver and 2nd overall. Third overall went to Tana Eberhardt, Cheyenne, at 322. These winners are all J2 bracket shooters.

The J2 gold went to Sarah Dey, Cheyenne, with 316. Rachel Dey, Cheyenne, being lone J3 shooter was moved up and stepped up to the competition with a silver win at 302. April Ewing, Casper, won the bronze with 292.

The Junior NRA Sectionals will be in Lander March 22-23 for small-bore and air rifle.

3 Position results Lander Valley Sportsmen

Nov 16, 2013 As winds howled outside, 4 shooters fired the 1st gallery match of the season in the warm, dry, and calm indoor facility. Three adults and a junior high power shooter trying smallbore against the USA/NRA 50' target for her 1st time. The match was 20 shots in each position for a possible 600 score.

Kenneth Lankford, Laramie posted a 555 to earn the match win. Roger Sebesta, Lander was top sharpshooter @517. Dan Thomas, Lander put 429 on the score sheet to take the marksman class award. Junior shooter Makayla Douthit, Walden, CO got her smallbore shooting started with a 423.

Dec 14, 2013 The final 3P event of 2013 was poorly attended. The travel weather was fine but maybe the Christmas shopping took its toll. The 2 Lander shooters showed they have lots of room for improvement. Sebesta 's 504 was match winner over Thomas' 442, which earned him the marksman award.

Jan 11, 2014 Lights were on, the fire and furnace cranked up, but only the match director turned out and the event cancelled. Instead it was turned into gun repair 101 to work on a CZ452 that needed sear adjustment.

The Feb 8th 3P will be the last 'open' of the season. Then on the 9th the Racy Clark 100 shot off-hand match will give shooters a chance to shoot the A-17 targets again. All safe shooters welcome. Programs on lysa.info

LANKFORD ADDS TO HIS NATIONAL RECORDS

The NRA has confirmed that the 794-28X score fired by Laramie shooter **Kenny Lankford**, is the new High Power Rifle National Senior Record for 200 yard 80 shot regional course-metallic sights. He fired the score at the Colorado State 200 yard reduced course championship held on April 20, 2013 at the Boulder Rifle Club, Boulder, CO.

The 80 shot regional course consisted of 4 20 shot stages including slow fire standing [197-3], rapid fire sitting [199-7], rapid fire prone [199-5] and slow fire prone [199-13]. Lankford shoots a Remington 700 in .223. The old record was by Oregon shooter, Nelson Shew sat at 766-15X since 2002. Lankford bested 14 other high power shooters to win the championship as well as setting the record.

This is the third National Record that Lankford has held. He formally held the National Open Record for 20 shots rapid fire sitting of 200-18, set in 1992 which still stands as a civilian National Record. He also won the High Tactical Rifle—Any Sight category at the 2011 National Championships at Camp Perry, Ohio. In 2012, he held Wyoming State Champion title in 4 Position indoor smallbore, 3 position indoor smallbore, Air rifle, Mid-range 600 yards and Wyoming State High Power Rifle. He repeated as WY State High Power Rifle Champion in 2013 at Cheyenne.

Lankford is a life member of the National Rifle Association, a life member and former board member of the WSSA, a life member and one of the founding members of the Laramie Rifle Range while still holding several board positions. He began his shooting competitively in 1966.
