#### THE PRESIDENT'S **COLUMN:**

As the shooting seasons close for 2022, Wyoming State Shooting Association has had some success in continuing with our programs. As major world and political events has hastened the availability of ammunition and components, programs have slowed. The far-left desire to protect criminal activities and to slow prosecution of such criminals has seen a major push to declare lawful citizens as the problem due to ownership of arms. Rarely is it seen where a legal purchase of firearms leads to crimes. Most arrested for violation of our laws have made a career of it and rely on 9-5 city politicians and staff to scoot it under the rug. Hopefully the recent of movement that has shown the shift in majority in the Congressional house and maintained a close count in the Senate, will continue to allow responsibility and accountability within our national borders. THE SHORTAGES OF PRIMERS, POWDER, **BULLETS AND CASES IS ONGOING** AND WHERE NOW AVAILABLE, THEY ARE AT MUCH HIGHER PRIC-ES WHICH SERVE TO REALLY DIS-COURAGE COMPETITION. ## **Greetings!**

PREFERENCE POINTS Did you add your comments to Game and Fish before the Aug 1st deadline on the Preference Point (PP) system that is being proposed for change? I understand a squaring of the past PP's is one idea being considered. The PP system was initiated in 1995. Maybe G&F has an idea of how many PP are being held at present. Note- the new system is only for moose and sheep at this time. OK, so your 20PP's would give you 400 entries into the pool. Sounds good until you realize every other PP holder will be in the pool with squared numbers. Does it really change your odds of drawing one of the limited tags? The present system guarantees a tag IF you live and keep purchasing PP long enough. Not so even with 400 chances in the pool due to the limited number of tags being far less than applicants.

Another change has been imple-

mented via the WY legislature, that being a change in the percentage of tags in the pool. In the past the available number was divided into 75% resident and 24% non-resident. Now it will be 90% R and 10% NR.

CORNER CROSSING I'm disappointed that G&F has not issued a comment on the issue. Seems they should be in a favorable position as it would open more public lands. I realize G&F needs land owners assistance especially in winter range forage for wildlife and also when doing trapping and collaring studies.

The four Missouri hunter's case is expected to be heard in Federal Court this summer. WOW! Land owner Fred Eshelman has filled a 7 million dollar claim for the crossing of his corner point and air space. Seems that 'air space' would also involve aircraft or make them subject to the same trespass charge.

Co-chairman of WY Back Country Hunters and Anglers, Buzz Hettick, has set up a GO FUND ME account set up on behalf of the four hunters. Please support if concerned. With the case in Federal Court more than just WY is interested in the outcome. Colorado anglers have a dispute with a private club and Utah hikers and skiers have a dispute with US Forest Service and a land owner on an access road. Be safe and enjoy the Wyo outdoors. Merry Christmas and wishing you well in 2023. Best wishes, be safe.
