## From the President:

Hello All,

I am writing to introduce myself to you as I have been elected to the WSSA Board as President. This is an organization I have always been proud to be a member since 1970 and I hold Life Member 14.

I have been involved in the shooting sports since 1966 when I was 13 in. I shot my first state match that year in small-bore rifle as a sub-junior. I started shooting high-power in 1970 shooting in my first Wyoming state high-power match as a junior. I am classified Master in International, Metric, Conventional Small-bore, High Master in High-power and Mid-Range rifle. I am still active in High Power and Small-bore rifle shooting and have shot in seven states this year alone. I have always resided in and around Laramie, Wyoming, having worked 45 years in the rail welding industry for all railroads while traveling to all 50 states and five countries. I retired this year and live in paradise in Albany, Wyoming.

I was on the WSSA board in the later 1970's and early 80's as Competitions Director. During those years, I was able to arrange for all State championships in the state, arrange for Camp Perry National Match participation four times with 6-shooter civilian teams and 2-shooter Whistler Boy Junior teams. These teams were DCM

(Director of Civilian Marksmanship, now CMP) and WSSA funded. This also involved taking care of all vintage trophies (including Iron Mike), over 30,000 rounds of ammo, 12 M-1 and eight M-14 rifles. I left the board in 1985 when the City of Laramie started an ad-hoc committee to investigate the possibility of a shooting range on city property. I was asked to be on this committee. In 1986, the committee was instrumental in obtaining 320 acres for the City of Laramie, starting the Laramie Rifle Range Club. We started from scratch, building the Laramie Rifle Range, which has expanded to include 10 different ranges operating simultaneously. These ranges include a 50 yard pistol range, 100 and 200 yard multipurpose ranges, 50 yard practical pistol range, three each Three gun ranges, a casual shotgun range, rim-fire walking range, and a High-power rifle range out to 1000 yards with gong setups to 1200 yards. I have served as President and Treasurer of the Laramie Rifle Range through the years and currently am on the board.

If I have not had the pleasure of meeting you, I would welcome information on yourselves. I plan to contact each of the WSSA Board personally in the next week or so.

My future with the WSSA will involve reviewing its mission and vision, placing priority on all shooting with major emphasis on our younger shooters, while utilizing outside organizations such as the NRA, CMP, USA Shooting Sports, the State

of Wyoming and its many municipalities.

The United States of America has a profound record and history of Firearms ownership allowed under the Second Amendment of the United States constitution. This amendment and others form this nation of people and laws. Much of this history has its flaws, which puts on display for the world to see, certain acts of evil against all. This nation is becoming increasingly split as many place the blame on firearm ownership for this destruction. I am in the camp which places the blame on irresponsible human behavior and the lack of enforcement of laws and punishment for those that disregard them. Many of those that attack the Second amendment right are forthright in protection of the rights of perpetrators as victims, while placing the burden of guilt on the offended. A huge, vocal platform exists in the entertainment industry that profits from the manufacture of media that portrays and reinforces the illicit use of firearms while accepting the loss of human life as normal everyday occurrences. Yet, this industry is on the forefront declaring responsible firearm ownership as threatening while garnering billions of profit from the public. I view this as a dangerous use of the First Amendment rights afforded to all.

Currently the national and many local media outlets are being increasingly biased in their news reporting, segregating much of public events into two forms of reporting: biased reporting that serves their agenda and non-reporting of public events that do not serve their agenda. This is a flagrant use of the First Amendment that throws gas on the warming fire of all.

As the NRA has endured increased attacks from these industries and biased reporting that will not display

responsible use of firearms nor the massive education efforts undertaken by this organization.

Use this in your arguments in defending your rights: How often have you seen major networks or major movie corporates show bullseye or Olympic style shooting? Compare this to being surprised by instant commercials showing firearms being shoved in someone's face, humans being shot at in action scenes, or violent disrespectful confrontations involving physical attacks; all when you wanted to watch a basketball game. Perhaps instead of increasing regulations and taxes to the lawful firearm owner, legislatures should start taxing the entertainment industries per bullet fired at human souls per view or for every fire or bomb set off in a felony scene.

There is no greater place than the United States of America and this was created by the well thought out guidelines in the United States

Constitution and the Bill of Rights. Families have progressed for years following these guidelines in a respectful manner. But many others now have forgotten basic respect for human life and how firearms' freedoms have protected our great families and nation.

There is much work to be done in support of our culture and freedoms as we know it. I hope I can continue to be of a positive role in helping this along.

## From The Legislative Director


**Greetings:**

### We could use some help on the board of directors:


