Our special guest present were Janet Milek and Nish Goicolea from Game & Fish, and of course, Dicky Shanor from the Department of Education. Please note that during this meeting, Coach Phillip Dobkins was voted to Junior Small Bore Director position, leaving the Junior Hi Power Director, and the Vice President positions open.

Guest Basic Information Briefings and Comments.

Our guest were very eager and informative. Dicky informed us that the Wyoming Superintendent of Public Instruction Megan Degenfelder, and all of the Department of Education was working with the Game and Fish, and other organizations to promote firearms safety training for Wyoming youth. Dicky noted that the school districts are the ones who decide what subjects, books, and curriculum, is taught in their schools. Janet explained that the Game and Fish were working very hard to ensure that everyone that passed the hunter safety course had to at least demonstrate how to safely handle firearms, (sometimes non live firing, inert, drill firearms, but with operational functional actions) as well as pass a written exam. Nish went on to explain that they are working with the Department of Education to certify/qualify teachers from all of the school districts that want to learn, so that teachers can instruct the hunter safety course. Our Guest expressed hope that the Wyoming State Shooting Complex would have the facilities to help with this training & education.

Paul opened the meeting by thanking everyone for coming. Paul noted that these are crazy times we live in. The current onslaught of negativity toward firearms, our

constitution, and basic way of life seems under attack from all sides. Paul encouraged us to remain steadfast and do what we can to promote the shooting sports. He reminded us, although progress is slow, we should maintain our commitment to put firearms education back in class rooms. Paul noted that there were open positions on the board.

<u>Discussion:</u>

It was decided that no immediate action was needed after the meeting with our guest. From now on, we will have to pay if we want to continue to use the Bucking Bronc logo/emblem. We don't want to go to the 4-h championships in Douglas this year, but we will send money.
